#### Facility, Check-In, and Briefings:

**Trial Times:** Please note the different check in and briefing times for these trials.

#### General Briefing and Judge's Briefing for all Starter Novice competitors only will begin at 8:30AM.

General Briefing no earlier than 10:00AM for all other classes/competitors; Novice Judge's Briefing will follow General Briefing. Trial 1 will begin no earlier than 10:15AM with Novice C. Approximate times for each class will be determined once entries have closed and will be sent out with your trial confirmation. Trial 2 will start no earlier than 1:00PM with Novice Judge's Briefing

Monadnock Humane Society

- Doors will be open at 8:00 a.m. You may arrive to the trial site before 8:00am, but the doors will open to competitors at 8:00. General Briefing for Starter Novice classes will begin at 8:30am.
- We will allow crating inside our facility for this trial, but space will be limited. Your car is easily accessed and working out of your car is an option. We encourage outdoor/car crating
- Chairs are available to competitors, or you may bring your own chair.
- Our training center accommodates a small number of spectators. We reserve the right to limit the number of people in our Training Center as we feel necessary.
- We will have two General Briefings. The first at 8:30am for all Starter Novice competitors. The second
  General Briefing will occur just prior to the start of the Novice class for Trial 1 (approximately 10:00am), and
  as needed for Trial 2 competitors
- Move-ups will be allowed according to CDSP Obedience Regulations between trials
- FOOD: Coffee, bottled water and snacks will be available to competitors. We will have approximately 30 minutes between Trial 1 and Trial 2. Our committee will provide a light lunch- pot luck style. There are many restaurants within a few miles of MHS. No Hospitality- SORRY

#### A, B and C Classes:

**Starter Novice**-A-class is for dogs who have not earned any other obedience title or Qualifying score in any obedience registry. B-class is for dogs who may have earned a BN title in any obedience registry, but not earned a Qualifying score the Novice class in any obedience registry. The C-class is for dogs who have earned their SN-C title from CDSP, but does not have a Qualifying score in Novice from any obedience registry.

**Novice-**A-class is for dogs that have never earned an Obedience title in any registry

B-class is for dogs that have already earned an Obedience title in any registry

C-class is for teams that have already earned their CDSP Title in Novice (CD-C) in either Novice A or Novice B. Dogs may enter Novice C, in addition to Open and/or Utility classes.

**Open**-A-class is for dogs who have earned their CD-C, but not their Open title in CDSP Obedience.

B-class is for dogs who have earned their CD-C, and have earned a CDX in another obedience registry (AKC, ASCA, UKC, CKC...)

C-class is for dogs who have earned their CDX-C title.

**Utility-**A-class is for dogs who have earned their CDX-C, but not their UD-C title.

B-class is for dogs who have earned their UD-C title. Utility B will have three different orders of exercises included from Novice, Open and Utility in each order. A team cannot enter both Utility B and Utility C at the same trial.

C-class is for dogs who have earned their UD-C, OTCH-C or UDX-C title. Utility C will include all the Utility exercises with three different orders of exercises. A team cannot enter both Utility B and Utility C at the same trial.

**Versatility** -A- class is for dogs who have earned the CDSP Novice obedience title (CD-C).

B-class is for dogs who have earned the CDSP Novice obedience title (CD-C) <u>and</u> any other Open or Utility qualifying leg or obedience title in any registry.

C-class is for dogs who have earned a CDSP Versatility title (VT-C) in either the A or B class.

<u>Awards:</u> A Qualifying Rosette will be awarded to each team who earns a score of 170 or higher in each class (or a 185 or higher in any of the "C" classes). Placement ribbons will be given to the top four scoring teams in each class. A, B and C classes are placed separately.

First Place- Blue Second Place-Red Third Place- Yellow Forth Place- White

**New Title Rosettes** will be given to any team earning a new title at our trials. Please let us know on your entry form if you hope/expect to earn a new title at our trials.

A Rosette will be awarded for **High-In-Trial** upon completion of each trial to the highest scoring team in all classes (except Starter Novice). In the event of a tie in score, a run-off will occur.

Additional Special Awards may be given out at the end the trial and/or class.

\*From southeast (Boston): Take Route 2 West. In Gardener, MA pick up Route 140 North to 12 North. Follow 12 North to the traffic light in Keene, NH (Agway on left/ Cocoplum Appliances on right). Turn left onto 9 West. At the next intersection, follow the rotary onto Route 10 South-3rd exit off the rotary. MHS is about one mile down Route 10 South on the right.

\*From southwest (Springfield, MA): Take Route 91 North to Exit 28A (Northfield, MA). Turn right off the exit. At the "T" turn left onto Route 10 North. MHS is approximately 30 minutes on the left.

\*From the east (NH): Follow Route 101 West, through the Route 12 intersection, to the traffic circle in Keene. Take 3rd exit off of circle to Route 10 South. MHS is about a mile down Route 10 South on the right.

#### **Jump Heights**

Dogs are not required to be measured the day of the trial or prior to judging. However, judges have the option to measure any dog prior to his/her performance if the dog appears to be entered in a group lower than might be indicated by his/her registered shoulder height. Jump heights may also be modified based on physical challenges that a particular dog may face.

Height at withers	High/Bar Jumps (inches)
5.5" and under	4
8.0" and under	6
11.0" and under	8
13.5" and under	10
16.0" and under	12
19.0" and under	14
21.5" and under	16
24.0" and under	18
27.0" and under	20
Over 27"	22

Veteran dogs (seven years and older) may jump 2" lower than regular jump height indicated on above chart. **The Broad Jump distance will be twice the jump height.** 

**Note:** If modifying your dog's jump height, select the <u>modified height</u> on your entry and check the box to indicate modified height. You must also submit an Exercise Modification Form to be signed by the trial judge and attached to your score sheet. An Exercise Modification Form must be completed for <u>each</u> trial. #### **Notice to Competitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of CDSP Obedience rules and regulations including but not limited to the following rules regarding entry:

- This trial is open to all dogs being at least six months of age, including purebred and nonpurebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs must be registered with CDSP Obedience to compete. A one-time registration form is available and must be submitted DIRECTLY to the CDSP Obedience office (NOT to trial hosting organization) before the date that a team first submits an entry in a sanctioned trial. We regret we cannot accept an entry without a valid CDSP registration number.
- Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.

- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. A dog or handler who suffers an injury and/or illness or bitches that come into season after the closing date may be eligible for a 50% refund of their total entry fee. Written request for refund must be made to the Trial Secretary BEFORE the end of the event November 16<sup>th</sup>, 2024. Please provide documentation from your veterinarian or physician. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- All dogs shall be shown in a flat buckle or snap collar, or properly fitted martingale (limited slip) collar.
   No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are allowed. Body harnesses may be worn only due to medical reasons and the owner must furnish a veterinarian's note stating this. Collars may have tags. The leash may be no longer than 6' and made of fabric or leather.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes.
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- Dogs with disabilities are allowed and encouraged to compete provided that the dog does not show evidence of being in pain or discomfort.
- Upon successful completion of each exercise, the owner may choose to give the dog food as a reward.
   Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets and only be present in the owner's hand upon completion of all features of an exercise after the judge has said "Exercise Finished". This must be done before the team begins to move forward to the next exercise as directed by the judge. - Dogs must remain under control at all times whether on or off leash while on show grounds. Day kenneling only is permitted.
- This event will be held indoors on Top Dog rubber flooring.
